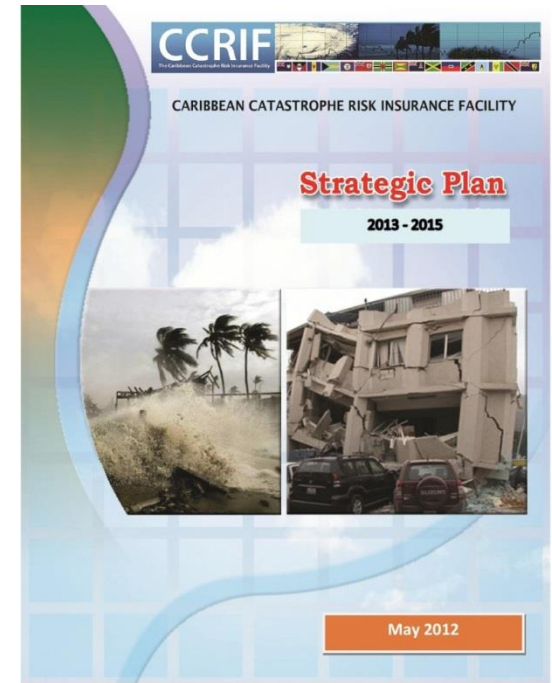
CCRIF Vision and Mission

- Plan reviewed annually and revised in response to the needs of the region

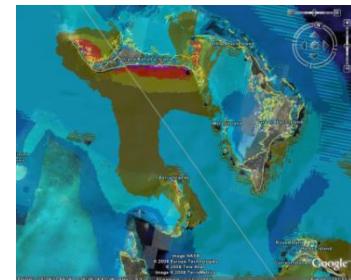


Strategic Objective 1
